### Dear friends.

The 2008 annual report of the Open Society Foundation provides basic information on supported projects and activities which, in fact, reflect situation in our society during this given period. As it was defined in our strategy, our primary ambition was to strengthen a position of our foundation in protection and promotion of human rights mainly in terms of legislation, public health, education, gender equality and media while focusing on marginalised groups of citizens.

Majority of the foundation's current program forms a mosaic of mutually intertwined topic coordinated in order to gain potential for defining issues, proposing or testing solutions and ideally, formulating concrete steps needed to improve the situation, e.g. via recommendations for government strategies. This is a style typically applied even on grant schemes for non-governmental organisations who are sensitive in their reactions to social injustice. Involvement of disadvantaged citizens, gender equality, non-discrimination, transparency, tolerance, independence of judiciary, impartial and professional approach of media, volunteerism and favourable environment for third sector and many others – form contents of projects which can be found in following pages. Research projects played an important role in portfolio of 2008 activities. Two key projects continued – one from the area of drug addiction prevention and the other one from cultural diversity. We published several interesting publications and organised discussions which offered space for exchange of information and debate on issues such as collection of ethnically sensitive data, cooperation of experts from various fields in mixed research team and a role new media and civil journalism. We also succeeded in organising fourth annual of Journalist Prize; finalised a program devoted to advocacy potential of Roma non-governmental organisations supported by CEE Trust; organised an international conference on populism and several international forums dealing with various topics and distributed grant money in the 1st call for proposals sponsored by Norwegian financial mechanism in the human rights field. On several occasions, we were honored to co-operate with excellent partners and gained inspiration for future work

We would like to extend our thanks to all our colleagues and partners, especially to Katka Vajdová, chairwoman of our Board of Trustees and Grigorij Mesežnikov, vice-chairman of this Board who concluded their mission in this managing body of NOS OSF after several years of devoted work.

# **NOS-OSF Founder GEORGE SOROS**

George Soros was born in Budapest. He lived through the Nazi occupation of Hungary and in 1947 immigrated to the United Kingdom where he graduated from the London School of Economics. At the London School of Economics, Soros became acquainted with the work of the philosopher Karl Popper, whose ideas on open society had a profound influence on his intellectual development. In 1956, he moved to the United States, where he accumulated a vast fortune through his international financial fund. His Quantum Fund is considered to be the most successful investment fund in history, averaging annual return of 31% during its 32 years of existence.

In 1979, Soros started focusing on philanthropy. He provided funds to help black students attend the University of Cape Town in apartheid South Africa. He is now the chairman of the Open Society Institute. In 1992 he founded the Central European University based in Budapest.

George Soros has written eight books and many articles about politics, society and economy published regularly in respected newspapers and magazines around the world. He has received honorary degrees from the New School for Social Research, Oxford University, the Budapest University of Economics, and Yale University. In 1995, the University of Bologna awarded Soros its highest honor, the Laurea Honoris Causa, in recognition of his efforts to promote open societies throughout the world. In 2002, he was awarded the Dayton Peace Prize for his extraordinary efforts to foster democracy and civil society in the Balkans.

#### **Open Society Institute**

The Open Society Institute (OSI), a private operating and grant-making foundation, aims to shape public policy to promote democratic governance, human rights, and economic, legal, and social reform. On a local level, OSI implements a range of initiatives

to support the rule of law, education, public health, and independent media. At the same time, OSI works to build alliances across borders and continents on issues such as combating corruption and human rights abuses.

OSI was created in 1993 by investor and philanthropist George Soros to support his foundations in Central and Eastern Europe and the former Soviet Union. Those foundations were established, starting in 1984, to help countries make the transition from communism. OSI has expanded the activities of the Soros Foundations Network to other areas of the world where the transition to democracy is of particular concern. The Soros Foundations Network encompasses more than 60 countries, including the United States.

# **EDUCATION**

The education program of the Open Society Foundation has been responding to the on-going challenges resulting from the reform of the education system in Slovakia. It is a reaction to the current Slovakia social and political context related to ever-changing government's policies and trends in European education. In co-operation with key actors, NOS – OSF has been supporting open society values, democratic principles and respect for human rights as inseparable part of educational reform and policy in tolerant and just environment.

Our own operational programs are designed to increase qualification level of our young people, to get acquainted with other cultures and to gain new experience via grant schemes and scholarship programs which have been well-established in the foundation since its very start. In the field of Education 6 grants were awarded in 2008 amounting to SKK 855 326,-.

# **Education Program**

The key idea of the program in 2008 was to support reform of education and education policy via enhanced participation of civil sector in the process and to include multicultural education into the education system in Slovakia.

# 14th Annual English Essay Competition

This annual program has been organized by the Foundation since 1995. Its goal is to motivate students to improve their English language skills, and support talented and creative students to develop original thinking and ways of expressing their views on current social and personal matters. The competition is designed for gymnazium students, competing in three categories (Junior: 1st and 2nd year; Senior: 3rd and 4th year; Anglophones: students of any grade who have studied at English schools abroad for more than 4 months and students of English bilingual gymnazia). In 2008, the competition was jointly organized by NOS-OSF, British Council and SAUA/SATE

- 2. "What can be done to keep schools safe and prevent violence.

# One-year Internships of Slovak Teachers at British Independent Schools (HMC)

This educational program was introduced in 1997 to allow young Slovak teachers to spend one year at private secondary schools in Great Britain in order to acquire new information and improve both their knowledge of subject terminology and teaching experience. The teachers teach their subject during the stay and at the same time provide tutoring for students.

# Roma Memorial University Scholarship Program

NOS – OSF has been operating this educational program in co-operation with the Roma Education Fund in Budapest since 2007. The aim of the program is to provide merit-based scholarships to full-time Roma students at universities in Slovakia, thus provide for their quality education.

# **PUBLIC HEALTH**

The Public Health Program aims to influence public health policy on social inclusion and application of human rights and justice through an evidence-based approach. NOS-OSF has mainly focused on overcoming marginalization of the Roma community, drug users and providing support for civil society organizations working in the aforementioned fields. The core of the Foundation's activities in this area lies in its operating activities.

# Harm Reduction Program

In line with preceding year 2007, projects implemented in 2008 focused mainly on cultivation and enhancement of initiated advocacy actions leading to increased quality and accessibility of public health services emphasizing harm reduction for illegal drug users.

#### Research

# Project to Evaluate the Implementation of Selected Drug Sections

A second stage of long-term research project took place in 2008. Research team was composed under leadership of OSF. Its ambition was to map and describe the issue of children and youth abuse of volatile substances, summarize it and propose steps for further research. The research takes form of structured telephone calls.

#### Education

A team from Social work department with the University of Matej Bel in Banská Bystrica continued in their course titled "introduction to harm reduction". The course was introduced in Bucharest, Romania and will be complemented by HIV/AIDS prevention sections. At the same time, the course was introduced to Roma health assistants with hope that this approach may spread around Roma communities. The course managed to draw attention of Labour Office staff, which led our training team to draft adapted version of the course for non-academic personnel.

In 2008, a legal consultancy for drug users called Plan B was. See Program partners part for more information.

Moreover, different partnerships of multiple levels were established in 2008. Starting with international partnerships, a co-operation with Addictology centre at the 1st Medical Faculty of Charles University in Prague, CR needs to be mentioned along with collaboration with OSI Roma Health & Harm reduction, Global Drug Policy Program, OSI, Helsinki Foundation for Human Rights as well as Brno consultancy for children and youth. On national level, we launched a co-operation with partners at the Ministry of Interior and Justice, General Prosecutor's Office, Presidium of Police Corps, Ministry of Labour, Social Affairs and Family as well as Association of Roma Assistants.

# Roma Health

The Foundation had launched Roma Health program for the first time in 1998. Throughout the decade, target groups kept changing (children, pupils from primary schools, Roma pupils' teachers, young adult Roma). In 2008, this program focused primarily on Roma mothers and youth from Roma communities.

18 field health workers were stationed in 18 Roma communities in Prešov, Košice and Banská Bystrica regions. Financial support for work in 8 communities came from PFIZER Luxemburg pharmaceutical company. The program covered approx. 7 500 inhabitants from selected Roma communities. Advocacy activities included events organised by NOS OSF aimed at overall improvement and communication between government bodies (Slovak Government's Office, Slovak Public Health Authority) a NGOs working in the field of Roma health.

#### Program goals:

To alter Roma attitudes to hygiene and health - to themselves, their closest people as well as majority population

To improve communication between members of communities and physicians (or health care staff)

To improve level of personal hygiene of all family members

To improve level of information of Roma citizens on physical, mental, emotional and environmental health issues.

Number of Roma communities applying for program implementation: 42

Number of awarded Roma communities:

18 field health workers completed 4 specialized courses led by OSF lecturers and invited experts, especially from regional Public Health Authority offices.

April 16.-17, 2008, Levoča Number of participants: 22

Contents: working with target groups, motivation for work in Roma communities, hygiene in households, problems with primipara in maternal hospitals, how to prepare young mothers for hospital stays

Contents: How to facilitate health education for various target groups; how to use teaching aids (e.g. Fairy tales from clean wood) to train hygienic skills among Roma children, preparing young people for partnership and marriage.

# **GOOD GOVERNANCE**

The goal of this program is to contribute to the optimal functioning of institutions, establish favorable conditions for creating policies respecting human rights of marginalized groups, overcome discrimination and exclusion, and develop opportunities for participation in the management of public affairs. This year, the foundation awarded 57 grants amounting to SKK 34 375 397,21.

# Law Program

Law program key objective is strengthening the principles of rule of law, especially with a view of human rights protection and observation. In 2008, the activities of the law program aimed at combating extremism or hate crimes, support of free access to information and enhanced functioning of judiciary.

Sub-programs of NOS-OSF Law Program:

- A. Protection of human rights
- B. Transparency support
- C. Support of the judiciary

#### A. Protection of human rights

In 2008, this sub-program focused on human rights protection, primarily through its own operating activities and grant support to partner organizations combating extremism, or hate crimes. NOS-OSF co-ordinated operation of platform in organisations dealing with this topic. The objective of this activity was to create space for discussion about topics common to several organisations and arrive to joint NGO standpoints vis-à-vis government policies. Several platform members have become members of official Multi-disciplinary Integrated Group of Specialists Focusing on Elimination of Racially Motivated Crime and Extremism and drafted a joint proposal of amendments to amended Penal Code.

# 1. No Fear of Exremism - through information against extremism

The main goal of this project, launched in 2007, is to contribute to eliminating xenophobic and extremist behavior of youth through preventive activities and raising awareness. The project consists of two main components: a publication with multi-media DVD, and teachers' training. The project is primarily designed for teachers who encounter extremist behavior or those interested in this topic who are able to incorporate it into their instruction. Likewise, the project is designed for police officers specialized in the fight against extremism. The secondary target group is youth in general. The official project partners are: the Slovak Police Corps, Methodological and Educational Center, CA People against Racism and CA CEEV Živica. NOS-OSF also cooperates with a full range of relevant partners, such as specialized teachers' journals or psychological counseling centers.

# Operating activities: No Fear of Extremism

As part of its law program, NOS-OSF carried on with its education project titled No Fear of Exremism. The project is primarily designed for teachers at secondary schools, although other professions who come into regular contact with young people, participated, too. The official project partners were: the Slovak Police Corps, Methodological and Educational Center, CA People against Racism and CA CEEV Živica. NOS-OSF also cooperates with a full range of relevant partners, such as specialized teachers' journals or psychological counseling centers.

#### **Publication of training manual**

As part of this project, a manual was published with identical title. It is a series composed of textbook, workbooks and DVD. Textbooks describe the notion of extremism and its potential danger for society, it provides practical information for teachers who are or may be confronted with extremist acts in their students. Workbooks are supposed to enhance participatory education and DVD may be used for illustration of given topic and basis for discussion.

# B. Transparency Support - Access to Information

The aim of this sub-program supporting transparency is to increase transparency of public authority functioning through support of activities focusing on free access to information. As a part of this sub-program, NOS-OSF co-ordinates a platform of organisations and activists promoting Freedom of Information Act.

# Operating activities:

## **Competition INFOAct**

In 2008, NOS-OSF organized 6th INFOAct of the Year Competition. Broadly speaking, the competition aims at monitoring of implementation of the Freedom of Information Act. To be more specific, it evaluated nominations of citizens related to positive or negative responses to requests for information filed on basis of abovementioned act. The 2008 expert committee consisted of: Ema Beblavá, Transparency International Slovakia, Oldřich Kužílek, presenter of the Freedom of Information Act in the Czech Republic, Nataša Petrová, Association of local TV stations Slovakia – LOToS, MUDr. Martin Alföldi, Mayor of Šaľa town, winner of INFOAct 2007, Michal Kaliňák, spokesman of Prešov town. The winners were: Friendly Act of the Year District Authority of Bratislava – Petržalka; for Unfriendly Act: Town Hall of the Bratislava City, Office of Labour, Social Affairs and Family in Rimavská Sobota and Local Authority in Zacharovce. # Monitoring of drafted legislation

Since 2007, NOS-OSF continued in using its website (www.osf.sk) to monitor legislation in the process of preparation. The monitoring system consists of an early-warning system, listing selected new legislation in all stages of preparation, i.e. drafting and ratification by the Slovak government and parliament. The early-warning system allows interested parties to react to coming legislation and influence the drafting process.

#### A. Decade of Roma Inclusion

2008 small grant program - Res Publica - advocacy support - grant program

The program focuses on support of NGOs aiming at increasing civil engagement. Small grant program financed activities aspiring to strengthen mechanisms of inclusion, responsibility and participation, and to establish partnerships between public, private and third

sectors in order to enhance local ownership principle, to bring innovative solutions and fortify active participation of poor and marginalised population.

The World Bank Country Office Slovakia and Open Society Foundation Bratislava jointly announced Small grant program lasting from 2005 until 2008.

# International initiative Decade of Roma Inclusion (2005 – 2015) – ongoing operating activity

Decade of Roma inclusion 2005 – 2015 is an initiative supported by Open Society Institute and the World Bank. It is the first international attempt of this kind aimed at combating discrimination and providing for Roma equal access to education, housing, employment and health care.

#### Even in 2008 NOS - OSF:

- Supported alliances of Roma NGOs in Slovakia while monitoring national action plans' implementation and government's responsibility.
- Facilitated participation at meetings and workshops of International Steering Committee (international forum of representatives from countries who joined Decade of Roma inclusion).
- Conveyed its experience and provided consulting and expertise to representatives of government and individual departments involved in public policy formation.
- Supported initiatives aimed at developing new Roma leaders' capacities.

### B. TRUST for Civil Society – We are Equal

Its main objective is to build a network of non-governmental organizations, with the intent of creating an active alliance for influencing policy and protecting the interests of disadvantaged groups, and at the same time encourage involvement of the Roma via NGOs To develop innovative approaches in the fight against discrimination of disadvantaged groups, foster inclusion, and lessen prejudice on both sides (majority and minority).

In 2008, this program ended by providing outputs for publication and by targeted support to NGO projects which helped to achieve defined goals by their contents.

# Favourable Environment for Non-governmental Organizations

As our society undergoes dynamic development, NGO-related legislation is also subject to change. Several of the laws have been of temporary character, as they reacted quickly to the legal vacuum in the NGO-related area after 1989.

Currently, the legislative framework for the NGO sector is being revised and amendments are suggested that would correspond to the current situation in society. The current legislation, in its structure and content, is not favorable to the development of NGO organizations. Currently, there is for example no legislative framework for volunteer work, and no central registry of non-governmental organizations or definition of earning activity. Another pending issue is the public benefit vs. private or mutual benefit of various NGOs.

Since the Foundation perceives the legislative environment as the basis for civil society development, it considers this issue of the utmost importance.

Goal: to improve the legislative framework for non-governmental organizations

Providing information on involvement of NGOs in the legislative processes.

#### A. Distance learning for NGOs

The program meets the Foundation's goals in strengthening the long term sustainability of the non-profit sector.

The main program goal is to provide systemic training, skills and attitude development needed in gradual and permanent increase of professionalism in various jobs in the NGO sector. Training is aimed at management and development of NGO activities in Slovakia in the context of EU membership.

# Block Grant – Human Rights Protection Program

The block grant: Program aimed at supporting protection of human rights is designed for support of NGOs. The program is administered by NOS-OSF and is a part of the Financial Mechanism of the European Economic Area and the Norwegian Financial Mechanism with Iceland, Liechtenstein, Norway and Slovakia as donor countries. The aim of the Block grant –Human Rights Protection is to create efficient instruments for elimination of social stereotypes and prejudices; empower the judiciary in promoting human rights, multicultural life and non-discrimination; and foster respect for rule of law, democracy, human rights and freedom through funding of innovative and pilot subprojects.

In November 2007, NOS-OSF signed a contract with the Slovak Government Office on a non-refundable financial contribution from the EEA Financial Mechanism, Norwegian Financial Mechanism and the Slovak state budget. Based on this Contract, the Foundation will re-grant a total of EUR 1,588,236.00.

In the Program, the Foundation distributed non-repayable financial contribution (NFC) to NGOs in following four priorities:

#### Priority: human right protection support

Specific objective – increasing prerequisites needed for respect of basic human rights and freedoms in society and strengthening of capacity among NGOs operating in this field.

#### Priority: supporting right for equal treatment

Specific objective - supporting right for equality and non-discrimination; raising awareness while observing right for equal treatment.

# Priority: empowering judiciary

Specific priority - fostering rule of law, internal capacity and credibility of judiciary along with citizens' legal awareness.

#### Priority: enhancing multicultural environment

Specific objective – improved quality of relations in multicultural society with emphasis on advocacy of disadvantaged citizens' interests.

# 2% Direct Tax Allocation Funds

In 2008, the Foundation gained SKK 220 394,00 from the 2% direct tax allocation from natural and legal persons. The funds are traditionally used for complementing the Foundation's grant programs.

# INTERNATIONAL COOPERATION SUPPORT

International cooperation is present in all programs of the Open Society Foundation. The foundation uses the East East Program – Partnership Beyond Borders to share international experience and to promote civil society principles. The foundation's 2008 operating activities in the area of international cooperation focused on the development of philanthropy and sharing of experience with transformation processes with its Asian partners. In 2008, the foundation awarded seven grants amounting to SKK 2 552 343,00 and supported 19 experts to attend 9 events.

# East East Program – Partnership Beyond Borders

In 1991, George Soros came up with the idea of supporting cooperation between Central and Eastern European countries – he said, "people should travel, meet, share views and experiences with post-communist transformation." He stressed that Central and Eastern Europe had a lot to offer to each other and could help each other in many ways. The East East Program – Partnership Beyond Borders is based on this idea. This grant and operating program has been implemented since 1993.

# 2007 Journalism Award

Journalism Award is a forum of high-quality journalism open for journalists, representatives of media and broad public. The aim is to point out to high-quality work of journalists, thus enhance expert discussion on status and trends in the Slovak journalism. From the long-term perspective, the Journalism Award aims at assisting in increasing the professionalism and quality in the Slovak media.

Each year, the award is being announced in November in co-operation with partners. It is designed for journalists from all forms of media: print, electronic, national, local and regional as well as for Internet journalism. The contributions are reviewed by independent juries of three to five members.

Nominations were announced in each of 13 categories and juries selected one winner in each of them. 493 journalists took part in Journalism Award 2007 with 833 contributions. - 1. Expert committee members (EC) are voluntary advisors in a respective grant program;
- 2. EC members assist in fulfilling the mission and goals of the Open Society Foundation;
- 3. EC members participate regularly in the meetings of their committees or other important meetings; they actively participate in the work related to their program;
- 4. EC members act in line with the ethical code. That is:
  - a) all project information is confidential and cannot be made public before its implementation:
  - b) EC members cannot spread information that could damage the Open Society Foundation's reputation;
  - there can be no conflict of interest, while the **conflict of interest** is understood as follows:
    - if the EC member cannot stay impartial and objective in assessing the project submitted because the decision is made between the foundation's interests and his/her interests;
    - if the EC member (or a relative, close friend, business partner) has a financial interest in awarding the grant or signing the contract or in decision making related to the public procurement of the foundation;
    - if the EC member (or a relative, close friend, business partner) is in business partnership with the grant applicant or is its potential contractor or will end up in other conflict situations related to loyalty with the foundation that can influence the foundation's decision-making. This is also applicable in the case when no personal financial profit of the EC member from the grant is at stake;
    - it is up to the consciousness of the individual EC members to admit their partiality, involvement, real or potential conflict of interests
      - 1. in the case of direct involvement/partiality the committee member is excluded from discussion about the project;
      - in the case of indirect involvement/partiality (e.g. project supervisor), the committee member explains his/her position to the committee that decides about his/her participation in the discussion

If an EC member breaches any of the above provisions, he/she can be released from the EC.

- 5. EC members assist the program coordinator in guiding the program, stipulating its strategy and priorities
- 6. EC members are obliged to get acquainted with the project information supplied by the program coordinator and provide his/her assessment at the committee meeting;
- 7. EC members monitor the work of the grant coordinator.
- 8. EC members formally assess the performance of the committee in meeting the program goals and mission at the end of the year.
- 9. EC members are obliged to participate in the committee meetings. If they cannot participate they will excuse themselves in advance. If an unannounced absence occurs: if a committee member has three unannounced absences and has not participated in one third of all committee meetings in one calendar year, a request for his/her resignation may be filed.
  - a) in exceptional cases when an EC member has prepared for the meeting but cannot participate due to emergency reasons, he/she shall explain his/her position to the program coordinator in writing.
  - b) in the case of a long-term absence the EC member can find his/her substitute.

# FINANCIAL REPORT

The Board of Trustees approved the Open Society Foundation budget for 2008. The 2007 budget was set at SKK 41,600,000.00. The Board of Trustees set the foundation's administrative costs at SKK 6,750,000.00. # **Transparent Use of Financial Funds**

The Open Society Foundation is by law required to have its accounts audited (Act no. 34/2002 on foundations and civil code as amended). The audit results are public.

Slovakia's EU entry brought new administrative processes as required by EU legislation. One of the requirements is the application of new accounting regulations ensuring the comparability of final accounts regardless of the location of the subject's registered office. To achieve this, the EU passed legislation introducing International Financial Reporting Standards (IFRS). These standards are drafted by the independent International Accounting Standards Board. In addition to the general audit, NOS-OSF also prepares accounts according to the aforementioned standards, making its operations more transparent and trustworthy for international donors.

# **NOS-OSF Ethical Code**

The ethical code represents a set of rules that express the basic values of NOS-OSF's organizational culture and vision. The ethical code is binding for all members of the Board of Trustees, the Board of Elders, expert committees and foundation employees. The ethical code is an integral part of the foundation's organizational procedures and is a public document. Breaching the ethical code can lead to expulsion of a member from the Board of Trustees, Board of Elders, or expert committees or to the termination of employment.

The Open Society Foundation is an independent, nonpartisan institution that upholds the notion that an open society is the basis of democracy. NOS-OSF carries out its activities for the public's benefit and pursuant to applicable legal regulations.

#### **Open Society**

On a philosophical level, the open society concept is based on the idea that human understanding is imperfect and that nobody holds the ultimate truth. On a practical level, open society is characterized by the rule of law, respect for human rights, minorities and minority opinions, the division of power and a market economy.

Each and every NOS-OSF employee must be loyal to open society principles and cautious in attitude and deed so as to avoid jeopardizing the foundation's good reputation. Another NOS-OSF work requirement is making an effort to promote the foundation's goals, work respectfully, and adhere to the team spirit of the foundation. Work on the Board of Trustees, Board of Elders and expert committees is grounded in the high profile of members, and association with an institution or profession or certain elements in society with which the foundation wishes to cooperate in implementing its programs.

# Independence

Though the foundation welcomes government cooperation, since this can facilitate the foundation's programs and this support increases the impact of the foundation's work, the Board of Trustees must oversee these relations to ensure they do not interfere with the foundation's independence. The foundation needs to preserve its freedom to support programs that may precipitate government criticism, such as support for media independence and diversity, programs fighting corruption and efforts in the field of human rights, etc.

The principle of independence must also be applied in partnerships and co-financing.

#### **Impartiality**

Though promoting open society principles can be considered apolitical in the broadest sense of the word, it is important for the foundation to be impartial and to create an impression of objectivity. This requirement prevents us from employing persons publicly associated or identified with a political party or direct members of a political leadership.

#### **Conflict of Interest**

Supporting open society principles requires that support opportunities be equally available to all individuals in the country, and not limited or partially limited to a closed group. The basic principle for the NOS-OSF employee is to declare each real and/or potential conflict of interest. A "real conflict of interest" is understood as a material interest in programs supported by the foundation or family relations/ties to the organization that is the subject of the decision-making process. The same applies to purchasing of goods or services. A "potential conflict of interests" includes all situations and circumstances when the impression may arise that NOS-OSF employees mutually encourage each other's interests, even though there is no real conflict of interest.

The decision-making bodies need to be composed or predominantly composed of individuals with no personal and/or material interests in the programs supported by the foundation. In exceptional cases, when decision-making bodies want to support a project where one of its members has a material interest, they must ask a superior body for final approval. In practice this means that the expert committee needs to ask the Board of Trustees, which then consults the Open Society Institute for the final decision. If the decision-making body takes a decision, it should attach a justification and recommendation to the project. In the event that OSI decides to financially support the given program, the awarded amount can be deducted from the foundation's allocation. Such a decision comes under the jurisdiction of OSI.

Members of the decision-making bodies commit themselves to act in line with the Ethical Code, which they confirm by signing the document. The rules for expert committees/Board of Trustees can be adjusted as needed by individual programs. However, they must contain at least the following provisions:

- a) all information about the project is confidential and cannot be published before its implementation:
- b) expert committee (EC) or Board of Trustees (BT) members need to preserve and protect the foundation's good reputation:
- c) there must be no conflicts of interest; a conflict of interest is understood as follows:
  - If the EC/BT cannot remain impartial and objective in evaluating and assessing a submitted project because he/she must decide between personal interest and the interest of the foundation (real conflict of interests);
  - If an EC/BT member or his/her relative, close friend or business partner has a financial interest in awarding the grant or signing the contract or in decision-making in the public procurement of the foundation (real conflict of interests);
  - If an EC/BT member or his/her relative, close friend or a business partner is in financial partnership with the grant applicant or is its potential contractor or otherwise comes into conflicting situations as to his/her loyalty with the foundation that can influence the foundation's decision-making. This is also

- applicable cases where no personal financial profit for the EC/BT member from the financial grant is at stake (real conflict of interests);
- If an EC/BT member is associated in public with the submitted project/institution and an impression may arise that he/she is supporting his/her personal interests (potential conflict of interests), it is up to the conscious of individual EC/BT members to admit their partiality, involvement and real or potential conflict of interests. If in spite of previously taken measures (selection of committee members) a conflict of interests situation arises, the following measures shall be taken:
- in cases of direct involvement/partiality, i.e. a real conflict of interests, the member is excluded from discussion about the project and from the project in general, together with a recommendation that must be approved by a higher level body,
- in the event of indirect involvement/partiality, i.e. a potential conflict of interest (e.g. project supervisor), the committee member explains his/her position to the committee, which then decides on his/her participation in the discussion.
- d) if the EC/BT member breaches any of the above points, he/she can be excluded from the EC/BT based on a proposal by the program manager/coordinator or other EC/BT member.

#### Transparency and Equality of Opportunity

The open society principle is also promoted in the grant-making process such that granting methods and rules are as objective and transparent as possible, in compliance with applicable standards, and ensure that potential grant applicants have equal conditions for their grant applications. Granting principles are Part II of the Negotiation and File Procedures, "Awarding Grants-Grant Management." Employees make due effort to observe these principles.

This ethical code is updated at bi-annual intervals and is approved by the Board of Trustees.
